

Part A):

Paperwork must be sent to H. Noble Funeral Directors Ltd. No.1 Northdown Road, CT10 2UL, at least 3 WORKING days before the proposed interment.

Please make a note if the inscription on the stone is an additional inscription to a stone already in place in the garden of remembrance.

1 plot is made up of 2 separate holes next to each other, one with the marker stone (if purchased) on top and one with the vase on top (please see image below) You will not own the plot, the church does.

All fees must be sent to H. Noble Funeral Directors with this paperwork, 1x cheque for 'St. Peters P.C.C.' amounting to £ 166.00 for the Right of Burial, 1x cheque for 'H. Noble Funeral Directors' amounting to £ 50.00 for opening the plot. The optional stone marker is £ 50.00 made payable to 'H. Noble Funeral Directors'.

You may bury scatter tubes or loose bury the cremated remains in a plot, please indicate in the section on the reverse of this document.

Part B):

Church Consent and Regulations:

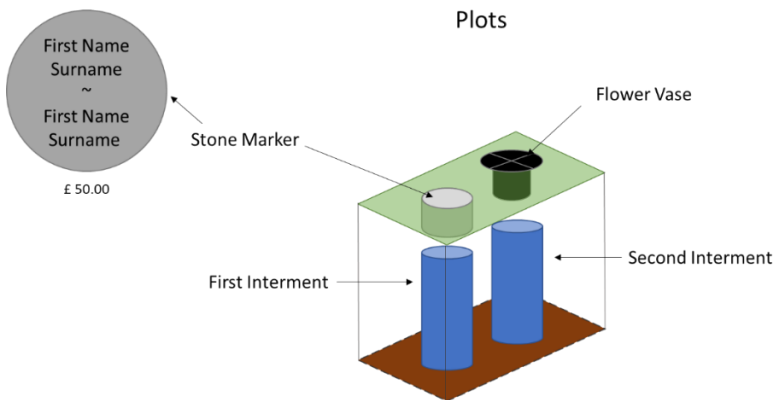
I being the person responsible named on Page 1 of this document acknowledge and accept the above and following regulations and statements regarding the interment of cremated remains in the newest burial areas in the Garden of Remembrance.

1. Each plot consists of two holes, one set of cremated remains per hole. (see below)
2. It is a requirement that ashes are buried in a scatter tube provided by your nominated funeral director or loose buried
3. Plots will be given a number, but this will only relate to the master grid plan. Marking of the individual plots with anything other than the approved markers and vase is prohibited and may be removed by church authorities. Flowers must be free of plastic and placed in the vases provided or in the long stone containers on either side of the altar in the Garden of Remembrance. (No other memorials are permitted)

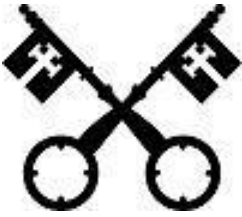
