All fees must be sent to H. Noble Funeral Directors (address above), 1x cheque for 'St. Peters P.C.C.' amounting to £ 79.00 for the Church fee for the right to fix a memorial plaque, 1x cheque for 'Roberts Stonemasons' amounting to £ 210.00 for the stone.

All paperwork and fees must be sent to H. Noble for administration and to ensure accurate records are kept. If you as the funeral director have ordered the stone, please ensure you notify H. Noble Funeral Directors. Applications will be returned if the client and or funeral director have failed to sign.

**Church Consent and Regulations:**

I being the person responsible named on Page 1 of this document acknowledge and accept the above and following regulations and statements regarding wall plaques

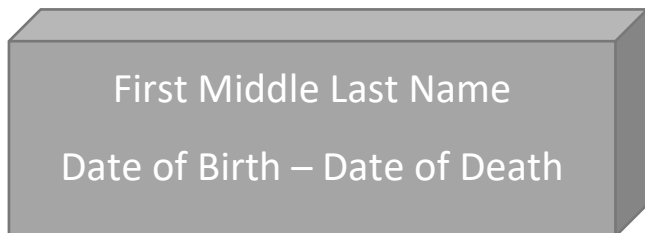
1. Stones are placed in date order along the wall and spaces can not be reserved next to each other
2. Stones can not be removed once fixed (otherwise causing risk of damage to the surrounding stones)
3. Stones should only be placed for those who have passed away and cannot be purchased in advance.
4. Criteria to qualify for a stone in the Garden of Remembrance must be met and is as follows:
  - Those whose name is entered on the church electoral roll of St Peter in Thanet at the time of their death.
  - Those who were regular attendees of St Peter in Thanet
  - Those for whom St Peter in Thanet was their family church.
  - Those for whom the cremated remains of a close relative are already buried in the Garden of Remembrance.
  - Those who lived in the parish of St Peter in Thanet
  - Those who have died in the parish of St Peter in Thanet
  - All of the above, and anyone else must have the consent of the incumbent of the parish, and when there is no such person then the consent of the Rural Dean of the deanery in which the parish is.

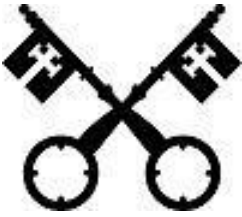
